Based on the performance in the admission test and the subsequent counselling, the following applicants have been provisionally selected for admission in Certificate in Organic Farming (COF) for the session 2026-27. The selected applicants may take provisional admission through online (<https://isr.rkmvu.ac.in/admission>) **with effect from 29th June, but not later than 5th July 2025** by paying the requisite fees of Rs.9300/-+ transaction charges (fees for the first semester: Rs.6000/-, admission fees: Rs.2000/-, Lifetime Subscription (one-time) for Alumni Network: Rs.1000/-, identity card: Rs.100/-, Registration fee: Rs. 200/-) by using net banking, debit card, credit card, UPI etc.

Admitted applicants have to reach Ranchi campus of the university with all required documents in original with one-set photocopies of documents for verification, to fill the admission-cum-registration form in between 08 July to 14 July 2026 during official hrs. Classes will commence from 15th July 2026, reporting time 10 am. Admitted applicants not attending classes for 3 consecutive days from the very beginning without prior written permission will run the risk of forfeiting their admission. The University expects its students to maintain a high order of discipline and academic integrity, which would be considered part and parcel of the course along with academic performance. The students should attend each and every class (both theoretical and practical) and the inability to attend should always be with prior permission only.
